RESULTS OF OPERATIONS

As at June 30, 2018, total net asset value of the Fund was \$419.8 million, a decrease of 5.8% from December 31, 2017. This was primarily driven by \$39.6 million in net redemptions and partially offset by an increase of \$14.0 million in net assets from operations.

During the past six months, the Fund's Series A units generated total returns of 2.4%. Over the same period, the Fund's benchmark, the S&P/TSX Composite Total Return Index (the "Index"), returned 2.0%. The performance of the Fund's other series is similar to that of its Series A units, except for differences in expense structure. For the return of the Fund's other series (if applicable), please refer to the "Past Performance" section.

The Fund experienced positive security selection and interaction effect, as well as positive sector allocation effect during the review period. Relative performance was most notably impacted by the Fund's positioning in the Materials, Information Technology and Financials sectors. This was partially offset by the Fund's positioning in the Energy and Industrial sectors.

The Index has now advanced in three of the past four quarters. Given the strength, the Canadian equity market set a new all-time high on June 22, 2018, surpassing the previous high set on January 4, 2018.

For the first half of 2018, six of 11 Global Industry Classification Standard sectors posted positive total returns. The best performing sectors were Information Technology (22.2%), Industrial (6.6%) and Real Estate (5.3%). Conversely, the weakest sectors were Utilities (-6.2%), Telecommunication Services (-5.0%) and Consumer Staples (-2.6%).

In Materials, overweight positions in Norbord Inc. (30.2%) and Methanex Corp. (26.1%) benefitted relative performance. These gains were partially offset by the Fund's sizeable position in Labrador Iron Ore

Royalty Corp. (-10.1%) (sold off prior to period-end), which underperformed, and lack of ownership of Nutrien Ltd. (12.8) (sold off prior to period-end), which outperformed.

In the Information Technology sector, significant positions in Constellation Software Inc. (33.8%) and CGI Group Inc. (21.9%) contributed positively to relative performance, while not owning Shopify (50.8%) detracted from performance.

In Financials, the Fund's underweight positions in Bank of Nova Scotia (-6.3%) and Royal Bank (-1.8%), as well as lack of ownership of Manulife Financial (-8.3%) benefitted relative performance. This was partially offset the Fund's significant weight in Intact Financial (-9.9%), which also experienced poor performance during the first half of 2018.

Peyto Exploration & Development Corp. (-29.6%) (sold off prior to period-end) and Tourmaline Oil Corp. (-17.3%) (sold off prior to period-end)) detracted from relative performance in Energy. These drags were partially offset by the Fund's significant weighting in Imperial Oil Ltd. (12.4%), which outperformed.

In Industrials, the main detractor included not owning Bombardier Inc. (71.6%), which outperformed its peers.

Trading activity remained steady during the first half of 2018.

Index performance comparison information is provided for reference only. It is important to note that the Fund's return reflects the effect of fees and expenses for professional management, while an index does not have such costs.

Average net assets of the series of the Fund that bear expenses have decreased for the six months ended June 30, 2018. This has resulted in a corresponding decrease in expenses. Income received from investments held, excluding net realized and/or unrealized gain (loss) on investments and derivatives, as applicable, remained relatively flat due to the results of the Fund's investment activities, including, but not limited to, those previously discussed for the period in review.

RECENT DEVELOPMENTS

So far in 2018, the environment for quantitative strategies in Canada has been mixed, with a strong first quarter followed by a declining second quarter. The Fund has been managed through various market dynamics and associated levels of quantitative efficacy. The portfolio manager is confident in the strategy's long-term potential and believes that its performance objectives represent a compelling value proposition. Going into the second half of 2018, the portfolio manager remains comfortable with the Fund's current holdings.

RELATED PARTY TRANSACTIONS

The Manager is an indirect wholly-owned subsidiary of Franklin Resources, Inc., a global investment management organization known as Franklin Templeton Investments. The Manager is the manager, registrar and transfer agent and a principal distributor of the Fund. The Manager provides or arranges for the provision of these services for day-to-day Fund operations, including the marketing, promotion and distribution of the Fund and portfolio advisory services. In consideration of these management and portfolio advisory services, the Fund pays the Manager a monthly management fee plus applicable taxes, based on the average net asset value of each series of the Fund (except Series O and OT, as applicable), calculated daily, as set out under Management Fees below. During the six months ended June 30, 2018, the Fund paid management fees of \$215,000 (2017–\$265,000).

Franklin Templeton Services, LLC (FTS) provides the Manager with fund accounting and portfolio valuation services in connection with the Fund, and provides certain back office administration services to the Manager. The Administration Fee, as discussed below, covers the cost of the services provided by FTS.

The Manager pays the operating expenses of the Fund, other than certain fund costs—which include, but are not limited to, the cost of compliance with new governmental and regulatory requirements, fees and expenses of the Fund's Independent Review Committee (IRC), borrowing and interest costs and investor meeting costs (as permitted by Canadian securities regulation)—in exchange for the payment by the

Fund of an annual fixed-rate administration fee of 0.23% plus applicable taxes, applied against the average daily net assets of the Fund (“Administration Fee”), except for Series PF, which has an annual Administration Fee of 0.15%, and Series O and OT, which have no annual Administration Fee. The Manager will pay all operating expenses of Series O and OT, as applicable, as part of its agreement with each investor. The Manager may, at its discretion, waive a portion of a series' Administration Fee or absorb certain fund costs. During the six months ended June 30, 2018, the Fund paid Administration Fees of \$34,000 (2017–\$36,000).

During the six months ended June 30, 2018, the Manager waived fund costs of \$1,000 (2017–\$1,000).

As at June 30, 2018, Franklin Quotential Balanced Growth Portfolio and Franklin Bissett Canadian Balanced Fund held 24% and 15% of the Fund, respectively.

Portfolio Advisor

Franklin Bissett Investment Management (the “Portfolio Advisor”), part of the Manager, provides investment analysis and recommendations and executes or arranges for brokers to execute portfolio transactions.

Principal Distributor

As a principal distributor of the Fund, the Manager markets the Fund and arranges for the sale of the Fund through dealers across Canada. The Manager may retain companies to assist in the sale of certain series of units of the Fund.

The Manager's affiliate, FTC Investor Services Inc. (“FTC ISI”), also acts as a principal distributor for Series F, O, OT, FT, PF and PF (Hedged) units of the Fund, as applicable.

For acting as a principal distributor of the applicable series, FTC ISI receives an inter-company service fee of 0.20% of the assets under management of the applicable series from the Manager with respect to those series of units.

Registrar and Transfer Agent

In addition to management and portfolio advisory services, the Manager acts as the registrar and transfer agent of the Fund. These services are in the normal course of operations and are covered by the Administration Fee paid by the Fund to the Manager.

Standing Instructions from the Independent Review Committee

The Manager relied on standing instructions from the IRC with respect to the allocation of any operating expenses not covered by the Administration Fee. The Manager relied, or may rely, on standing instructions from the IRC in respect of securities trades amongst mutual funds, investment funds or managed accounts managed by the Manager or an affiliate of the Manager. In both cases, the standing instructions require the Manager to comply with the policies and procedures presented to the IRC with respect to the above matters and to provide periodic reports to the IRC in accordance with NI 81-107.

MANAGEMENT FEES

A portion of the management fee paid by the Fund to the Manager is for trail fees and sales commissions the Manager pays to dealers (“Dealer Compensation”). The trail fees are a percentage of the daily average net asset value of each series of the Fund, which is held by the dealer’s clients. The remaining portion of the management fee is used to pay for portfolio advisory and administrative services related to the provision of portfolio advisory services. The table below outlines the Fund’s annual management fee, as well as the portion of the management fee used to pay for Dealer Compensation and for portfolio advisory services as an approximate percentage of the management fee for each series:

Certain institutional investors may negotiate the management and administration fees by written agreement with Franklin Templeton Investments.

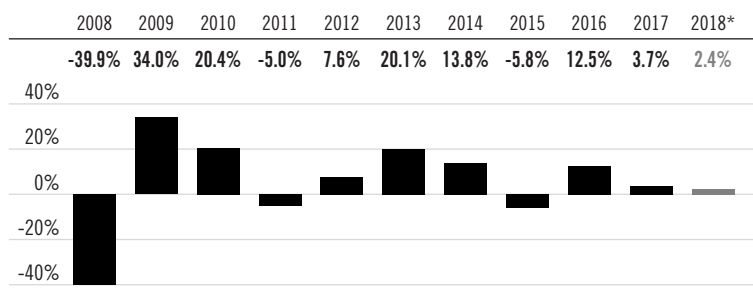

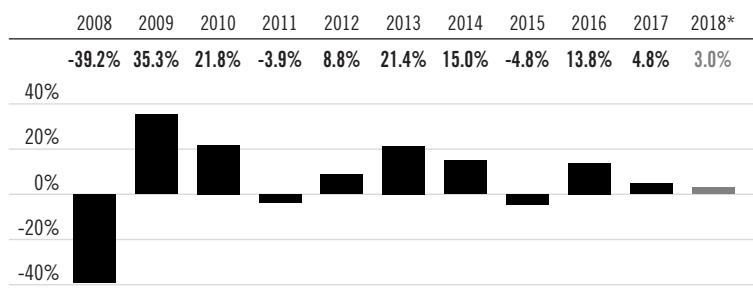

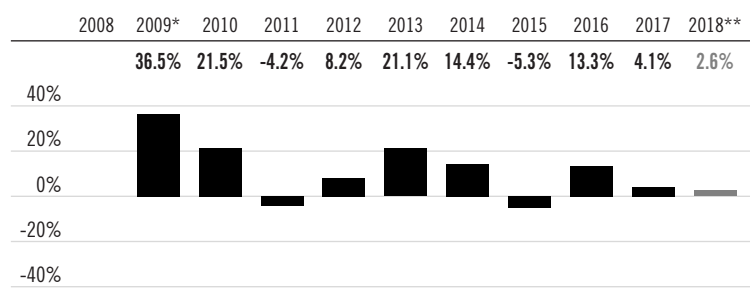

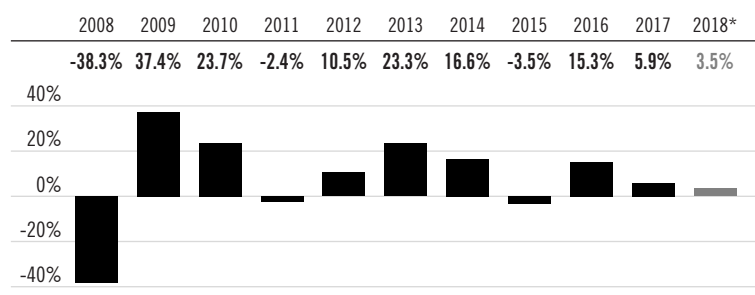

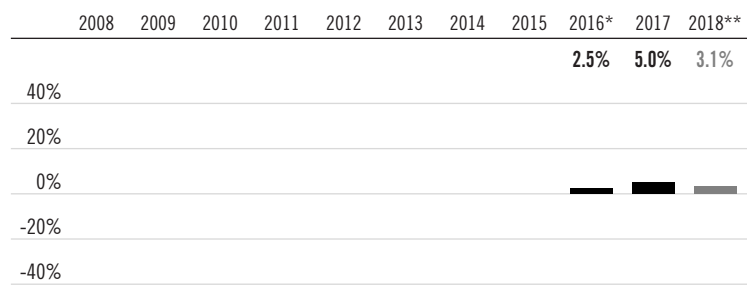

NOTES TO FINANCIAL HIGHLIGHTS

Net Assets per Unit:

- (1) This information is derived from the Fund's unaudited interim financial statements and audited annual financial statements. In the period a fund or series is established, the financial information is provided from the date of inception to the end of the period. In cases where the net assets per unit presented in the financial statements differ from the net asset value calculated for Fund pricing purposes, an explanation of these differences can be found in the notes to the financial statements.
- (2) Net assets and distributions are based on the actual number of units outstanding at the relevant time. The increase/decrease in net assets from operations is based on the weighted average number of units outstanding over the fiscal period. This table is not intended to be a reconciliation of opening and closing net assets per unit.
- (3) Distributions were paid in cash or reinvested in additional units of the Fund or both, and exclude distributions of management fee reductions to unitholders.

Ratios and Supplemental Data:

- (1) This information is provided as at the period-end of the year shown.
- (2) Management expense ratio is based on total expenses for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.
- (3) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of net asset value during the period.
- (4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio manager manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling each security in its portfolio once in the course of the relevant period. The higher the portfolio turnover rate in the period, the greater the trading costs payable by the Fund and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund.
