RESULTS OF OPERATIONS

As at June 30, 2018, total net asset value of the Fund was \$947.9 million, a decrease of 6.4% from December 31, 2017. This was primarily driven by \$69.2 million in net redemptions and partially offset by an increase of \$4.1 million in net assets from operations. The Fund paid or made payable \$176,000 in cash distributions to unitholders.

During the past six months, the Fund’s Series A units generated a loss of 0.3%. Over the same period, the S&P/TSX Composite Total Return Index gained 1.9%, and the FTSE TMX Universe Bond Index gained 0.6%. As the Fund invests in a portfolio of equity and fixed income funds, it employs a blended benchmark, the Custom Canadian Balanced Benchmark (the “Benchmark”), which returned 2.2% for the period in review. The performance of the Fund’s other series is similar to its Series A units, except for differences in expense structure. For the return of the Fund’s other series (if applicable), please refer to the “Past Performance” section.

The Fund’s overweight to smaller-capitalization Canadian equities negatively impacted both absolute returns and relative performance over the six-month period. This effect was partly offset by strong absolute returns from US equities. Relative returns were also weak across Canadian larger-capitalization, US and international equities, and only partially offset by positive selection within Canadian fixed income.

Despite growing trade tensions around the globe and the continued unpredictable nature of current US policy shifts, many financial markets fared better in the second quarter than during the first three months of 2018. Emerging markets, however, were weak across equity and fixed income. In contrast, North American equity markets rebounded, up low-to-mid single digits. The big winner for the first half of 2018 was the West Texas Intermediate crude oil price, which rose more than 22% over the reporting period.

Interest rates ended the period well off their 2018 highs. With US economic growth headed for a strong close to the first half of 2018, the US Federal Reserve (Fed) appeared ready for additional policy rate increases. Canada’s economy continued to slow, increasing expectations that the Bank of Canada (BoC) would lag the Fed in hiking policy rates.

The S&P/TSX Composite Total Return Index (TRI) finished the first half of 2018 with a modest 2.0% advance. As such, the Canadian equity market remains well entrenched in the current bull market which is now

more than nine years in duration. By comparison, the S&P 500 TR Index rose by 2.6% over the year in US-dollar terms (7.7% in Canadian-dollar terms), and the MSCI EAFE Developed Markets Index declined -2.4% in US-dollar terms (2.4% in Canadian-dollar terms).

The Canadian yield curve continued to flatten in 2018 as short-maturity Canadian bond yields rose substantially, while longer-maturity yields rose more modestly or, in the case of 30-year yields, fell.

The FTSE TMX Canada Universe Bond Index returned 0.6% over the first half of 2018, while its US counterpart (the Bloomberg Barclays Capital U.S. Aggregate Bond Index) lost 1.6% in US-dollar terms (3.2% in Canadian dollar terms). The short- and mid-term segments of the FTSE TMX Bond Index lagged longer- dated maturities, and corporate bonds outperformed the broad Canadian government index.

The S&P/TSX Composite Total Return Index gained 1.9% and the S&P/TSX Small Cap Total Return Index declined 1.3%. The Fund’s overall weighting to Canadian equities remains higher than the Canadian equity weighting in the Benchmark due to the relative underweighting in funds with larger-capitalization equities and relative overweighting in funds with smaller-capitalization equities. This positioning led to a negative relative return effect over the reporting period.

Index performance comparison information is provided for reference only. It is important to note that the Fund’s return reflects the effect of fees and expenses for professional management, while an index does not have such costs.

Average net assets of the series of the Fund that bear expenses have decreased for the six months ended June 30, 2018. This has resulted in a corresponding decrease in expenses. Income received from investments held, excluding net realized and/or unrealized gain (loss) on investments and derivatives, as applicable, remained relatively flat due to the results of the Fund’s investment activities, including, but not limited to, those previously discussed for the period in review.

RECENT DEVELOPMENTS

The asset mix as at June 30, 2018 was 65% in equities and 35% in fixed income and cash. Following some modest asset mix changes over the past six months, the period ended with an equity weighting about 1% higher than the fixed income weighting. The Fund’s neutral asset mix is 60% for equities and 40% for fixed income and cash. The portfolio manager is mindful of the CIFIC Canadian Neutral Balanced Fund category’s longer-term requirement of limiting equity exposure to 60%.

The portfolio manager continues to believe there is greater longer-term return potential for equities relative to fixed income, although this view has been tempered by the meaningful outperformance of equities versus fixed income over the last several years. In the equity fund allocation of the Fund, the portfolio manager continues to observe greater risk-adjusted return potential of Canadian equities in general, and smaller-capitalization equities specifically, and the Fund remains meaningfully overweight relative to the small-capitalization portion of the blended benchmark.

Fixed income allocation remains slightly defensive with regard to duration. In the portfolio manager's view, valuations are becoming stretched at this stage of the investment cycle. While it remains prudent to allocate fixed income portfolios with an emphasis on credit, where there is more yield, less duration, and more cushion against volatility, the portfolio manager maintains a slight preference for higher-quality assets.

RELATED PARTY TRANSACTIONS

The Manager is an indirect wholly-owned subsidiary of Franklin Resources, Inc., a global investment management organization known as Franklin Templeton Investments. The Manager is the manager, registrar and transfer agent and a principal distributor of the Fund. The Manager provides or arranges for the provision of these services for day-to-day Fund operations, including the marketing, promotion and distribution of the Fund and portfolio advisory services. In consideration of these management and portfolio advisory services, the Fund pays the Manager a monthly management fee plus applicable taxes, based on

the average net asset value of each series of the Fund (except Series O and OT, as applicable), calculated daily, as set out under Management Fees below. During the six months ended June 30, 2018, the Fund paid management fees of \$3.0 million (2017—\$3.4 million), after management fee waivers of \$14,000 (2017—\$16,000).

Franklin Templeton Services, LLC (FTS) provides the Manager with fund accounting and portfolio valuation services in connection with the Fund, and provides certain back office administration services to the Manager. The Administration Fee, as discussed below, covers the cost of the services provided by FTS.

The Manager pays the operating expenses of the Fund, other than certain fund costs—which include, but are not limited to, the cost of compliance with new governmental and regulatory requirements, fees and expenses of the Fund's Independent Review Committee (IRC), borrowing and interest costs and investor meeting costs (as permitted by Canadian securities regulation)—in exchange for the payment by the Fund of an annual fixed-rate administration fee of 0.19% plus applicable taxes, applied against the average daily net assets of the Fund ("Administration Fee"), except for Series PF and PFT, which have an annual Administration Fee of 0.15%, and Series O and OT, which have no annual Administration Fee. The Manager will pay all operating expenses of Series O and OT, as applicable, as part of its agreement with each investor. The Manager may, at its discretion, waive a portion of a series' Administration Fee or absorb certain fund costs. During the six months ended June 30, 2018, the Fund paid Administration Fees of \$365,000 (2017—\$409,000).

During the six months ended June 30, 2018, the Manager waived fund costs of \$2,000 (2017—\$1,000).

Portfolio Advisor

Franklin Bissett Investment Management (the "Portfolio Advisor"), part of the Manager, provides investment analysis and recommendations and executes or arranges for brokers to execute portfolio transactions.

Principal Distributor

As a principal distributor of the Fund, the Manager markets the Fund and arranges for the sale of the Fund through dealers across Canada. The Manager may retain companies to assist in the sale of certain series of units of the Fund.

The Manager's affiliate, FTC Investor Services Inc. ("FTC ISI"), also acts as a principal distributor for Series F, O, OT, FT, PF and PF (Hedged) units of the Fund, as applicable.

For acting as a principal distributor of the applicable series, FTC ISI receives an inter-company service fee of 0.20% of the assets under management of the applicable series from the Manager with respect to those series of units.

Registrar and Transfer Agent

In addition to management and portfolio advisory services, the Manager acts as the registrar and transfer agent of the Fund. These services are in the normal course of operations and are covered by the Administration Fee paid by the Fund to the Manager.

Standing Instructions from the Independent Review Committee

The Manager relied on standing instructions from the IRC with respect to the allocation of any operating expenses not covered by the Administration Fee. The Manager relied, or may rely, on standing instructions from the IRC in respect of securities trades amongst mutual funds, investment funds or managed accounts managed by the Manager or an affiliate of the Manager. In both cases, the standing instructions require the Manager to comply with the policies and procedures presented to the IRC with respect to the above matters and to provide periodic reports to the IRC in accordance with NI 81-107.

MANAGEMENT FEES

A portion of the management fee paid by the Fund to the Manager is for trail fees and sales commissions the Manager pays to dealers (“Dealer Compensation”). The trail fees are a percentage of the daily average net asset value of each series of the Fund, which is held by the dealer’s clients. The remaining portion of the management fee is used to pay for portfolio advisory and administrative services related to the provision of portfolio advisory services. The table below outlines the Fund’s annual management fee, as well as the portion of the management fee used to pay for Dealer Compensation and for portfolio advisory services as an approximate percentage of the management fee for each series:

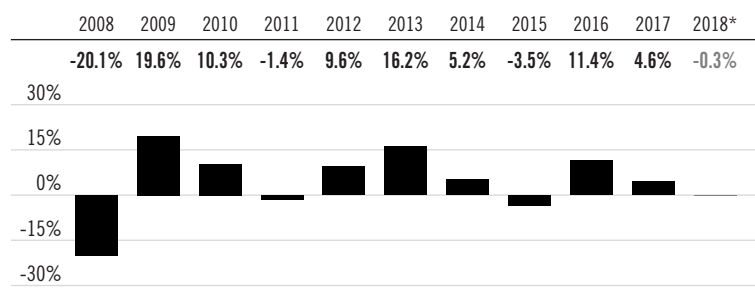

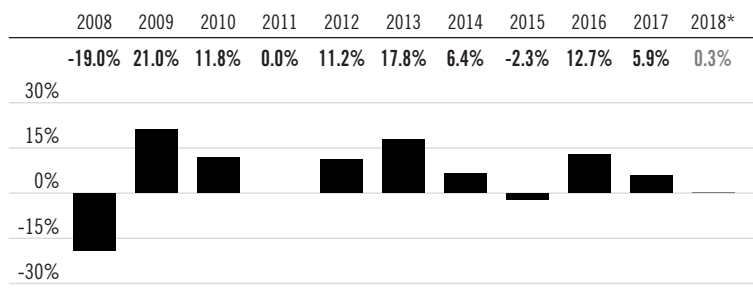

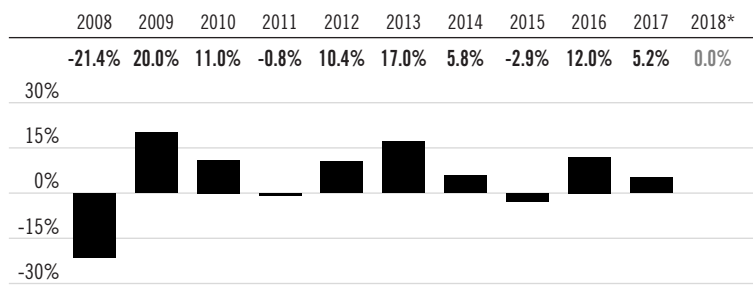

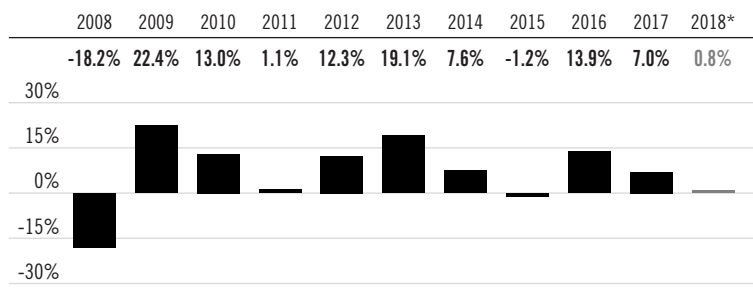

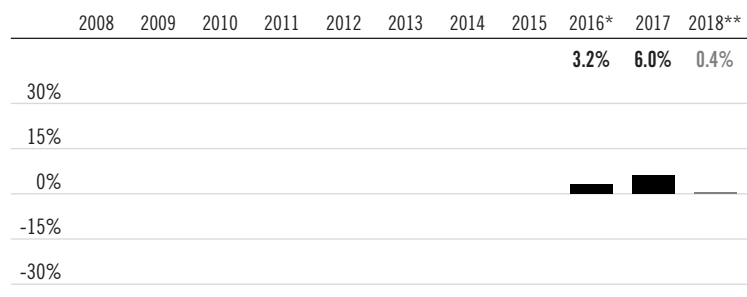

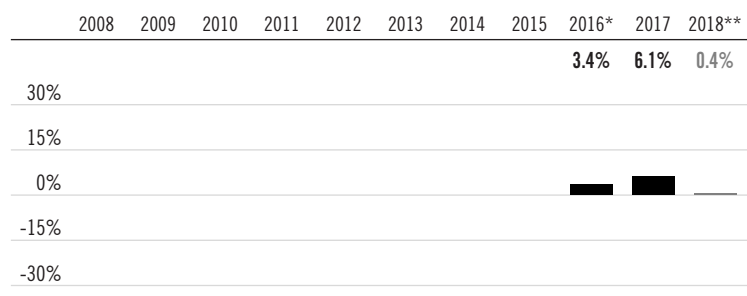

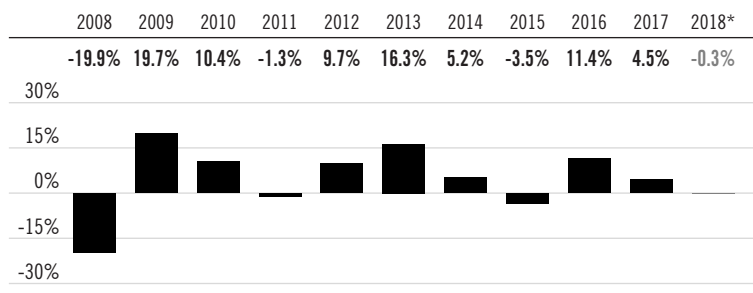

Net Assets per Unit:

- (1) This information is derived from the Fund's unaudited interim financial statements and audited annual financial statements. In the period a fund or series is established, the financial information is provided from the date of inception to the end of the period. In cases where the net assets per unit presented in the financial statements differ from the net asset value calculated for Fund pricing purposes, an explanation of these differences can be found in the notes to the financial statements.
- (2) Net assets and distributions are based on the actual number of units outstanding at the relevant time. The increase/decrease in net assets from operations is based on the weighted average number of units outstanding over the fiscal period. This table is not intended to be a reconciliation of opening and closing net assets per unit.
- (3) Distributions were paid in cash or reinvested in additional units of the Fund or both, and exclude distributions of management fee reductions to unitholders.

Ratios and Supplemental Data:

- (1) This information is provided as at the period-end of the year shown.
- (2) Management expense ratio is based on total expenses for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.
