How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Franklin Templeton has rated the volatility of this fund as medium.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.


How has the fund performed?

Year-by-year returnsThis chart shows how Series O units of the fund have performed in each of the past 3 years. The series did not drop in value in the past 3 years. The range of returns and change from year to year can help you assess how risky the series has been in the past. It does not tell you how the series will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series O units of the fund in a 3-month period over the past 3 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

The annual compounded return of Series O units of the fund was 8.77% since inception. If you had invested \$1,000 in this series of the fund since inception, your investment would be now worth \$1,375.

Who is this fund for?

Investors who:

- seek a global equity fund that provides exposure to incomegenerating securities of issuers in the infrastructure business
- seek a fund that follows a sustainable investment approach
- invest for the medium or long term

This series is also available in U.S. dollars.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series O units of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

1. SALES CHARGES

There are no sales charges for Series O units of the fund.

2. FUND EXPENSES

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2024, the expenses of Series O were 0.15% of the value of this series. This equals \$1.50 for every \$1,000 invested.

Annual rate (as a % of the series' value)

Management expense ratio (MER)

This is the total of the management and administration fee and operating expenses.

All fees and expenses are paid directly by you, see "Manágement and administration fee" below.

Trading expense ratio (TER)

These are the fund's trading costs. 0.15% Series expenses 0.15%

More about the trailing commission

No trailing commission is paid by Franklin Templeton to your representative's firm in respect of Series O units.



3. OTHER FEES

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fee	What you pay			
Management and administration fee	The fund does not pay a management or administration fee to Franklin Templeton for this series. Instead, you pay a management and administration fee directly to Franklin Templeton at the following rates: On the first C\$2.5M – 0.90% On the next C\$2.5M – 0.80% On the portion that exceeds C\$5M – 0.75% Certain institutional investors may negotiate different management and administration fees by entering into a written agreement with Franklin Templeton.			
Investment advisory services fee	You pay your representative's firm an investment advisory services fee, which you negotiate directly with your representative. This fee is paid for as long as you own this series of the fund. Franklin Templeton will collect the investment advisory services fee (plus any applicable taxes) from you on behalf of your representative's firm by redeeming units of this series of the fund in your account and remitting the amount to your representative's firm. The maximum annual investment advisory services fee that we collect on behalf of your representative's firm is 1.50%.			

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you will also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by securities law in your province or territory.
