### What does the fund invest in?

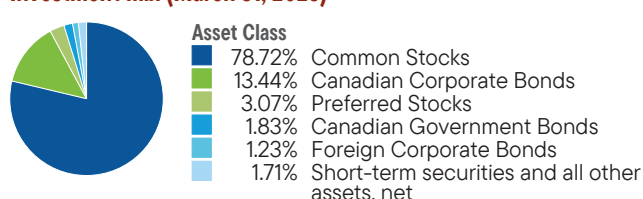
The fund invests primarily in Canadian and American dividend-paying preferred and common shares. The fund may, from time to time, invest in bonds up to a maximum of 25% of the fund's total assets. The fund may also invest up to 30% in a combination of equity securities of foreign issuers and foreign currency-denominated fixed income securities, and may exceed this threshold from time to time.

The charts below give you a snapshot of the fund's investments on March 31, 2025. The fund's investments will change.

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

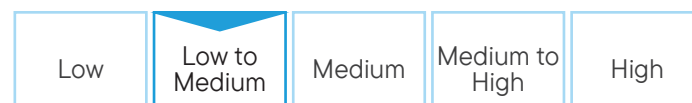
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

#### Risk rating

Franklin Templeton has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

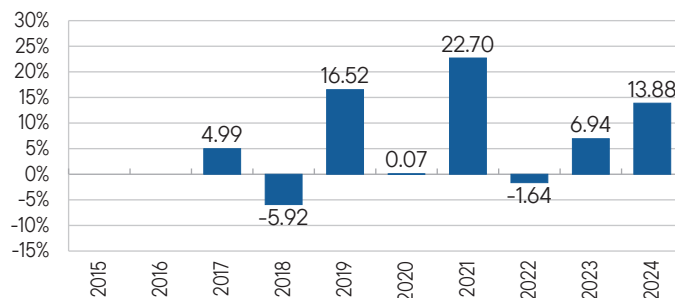
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

### How has the fund performed?

This section tells you how Series FT units of the fund have performed over the past 8 years. Returns are after expenses have been deducted. These expenses reduce the series' returns.

### Year-by-year returns

This chart shows how Series FT units of the fund have performed in each of the past 8 years. The series dropped in value in 2 of the 8 years. The range of returns and change from year to year can help you assess how risky the series has been in the past. It does not tell you how the series will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for Series FT units of the fund in a 3-month period over the past 8 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average return

The annual compounded return of Series FT units of the fund was 7.41% since inception. If you had invested \$1,000 in this series of the fund since inception, your investment would be now worth \$1,835.

### Who is this fund for?

#### Investors who:

- seek a fund that pursues dividend income, with the possibility of interest income and capital gains
- invest for the medium or long term

This series also seeks regular monthly cash flows from investment held outside a registered plan.

Series FT units are only available to investors approved by Franklin Templeton for whom Franklin Templeton does not incur distribution costs.

### A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

### How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series FT units of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other series, funds and investments that may be suitable for you at a lower cost.

#### 1. SALES CHARGES

There are no sales charges for Series FT units of the fund.

#### 2. FUND EXPENSES

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2024, the expenses of Series FT were 0.97% of the value of this series. This equals \$9.70 for every \$1,000 invested.

#### Management expense ratio (MER)

This is the total of the series' management fee, fixed administration fee and any operating expenses not covered by the fixed administration fee.

A switch from Series FT units of the fund to Series FT units of another fund will not be subject to switch fees. #### What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you will also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by securities law in your province or territory.
