### Investment objective and strategy

The Fund seeks to achieve long-term capital appreciation by investing primarily in equity securities of companies outside Canada and the United States.

### **Investment process**

## Define the investment universe

Consider companies that have strong balance sheets, good management, offer unique products or services, or have strong niche positions locally or globally.

## Apply fundamental analysis

Use a bottom-up approach to evaluate current and future prospects and ensure that accounting compliance, data accuracy and global comparability goals are met.

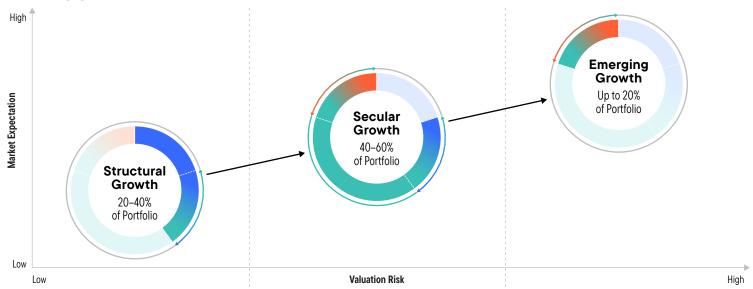
## Select securities & construct portfolio

Build a diversified portfolio with roughly 40 to 70 stocks across 10 to 20 countries. Complement larger core holdings (approximately 80-90%) with tactical investments (approximately 10-20%) in smaller companies that have met our ESG criteria.

## Monitor continuously

Re-examine a current holding when unit growth/earnings deteriorate, valuation exceeds expectations, and when there is an adverse acquisition or a loss of franchise or market share.

### **Defining growth**



### Idiosyncratic drivers of return uncorrelated to growth and market cycles

- · Highly opportunistic
- Capitalize on industry and/or company-specific changes
- Duration and/or magnitude of growth often mispriced

## Established superior business models and sustainable long-term growth opportunities

- Consistency and compounding of returns provides steady growth, stability, and downside risk management
- Thematic backdrop
- Duration of growth often mispriced

## Exposure to nascent or disruptive industries and innovative business models

- Potential for solid returns and participation in long-term upside
- Large addressable markets and very fast growth
- Risk of failure; positions sized accordingly (less than 1%)
- Magnitude of growth often mispriced
